Prayer in the writ petition is for setting aside the Award dated 07.07.2020 (Annexure P-5) passed by respondent No.1-Permanent Lok Adalat (Public Utility Services) SAS., Nagar, Mohali, whereby the petitioner has been directed to correct the spelling of the name of parents of the applicant from 'GURBHACHAN SINGH' to 'GURBACHAN SINGH' and 'TAJINDER KAUR' to 'TEJINDER KAUR'.

Learned counsel for the petitioner, is unable to deny that the matter is squarely covered against the petitioner in view of the judgment of Hon'ble Supreme Court in **Jigya Yadav (minor) (Through Guardian/father Hari Singh) Vs. C.B.S.E (Central Board of Secondary Education) and others, in Civil Appeal No.3905 of 2011, decided on 03.06.2021 .**

Present writ petition is accordingly dismissed. Necessary action be taken by the petitioner, in terms of order dated 07.07.2020 within four weeks from receipt of certified copy of this order.
