The hearing of the case was held through video conferencing on account of restricted functioning of the Courts.

As per the office report, notice issued to the respondent has been received back served through his counsel in the trial Court. However, he remains unrepresented.

On 13.09.2021, the following order was passed:-

“ This petition has been filed by the wife seeking the transfer of the petition filed under Section 9 of the Hindu Marriage Act, 1955, bearing case No.HMA/32/2021, titled as “Baljit Singh vs. Karamjit Kaur”, pending in the Court of Additional District Judge, Family Court-I, Jalandhar, to the Court of competent jurisdiction at Ludhiana.

The petitioner claims that she got married to the respondent on 02.11.2014 and they have been blessed with a male child. She claims that presently, she is residing with her parents at Ludhiana and the distance between Jalandhar and Ludhiana is more than 70 Kms. The petitioner further claims that she cannot properly defend the petition at Jalandhar.

The learned counsel representing the petitioner places reliance on the following litigations pending in District Courts, Ludhiana:-

(i) Complaint No.COMA/10221/2020, under the Domestic Violence Act, 2005.

(ii) FIR No.0018, dated 21.02.2021, registered under Section 406/498-A IPC, at Police Station Women, Ludhiana

(iii) Under Section 125 Cr.P.C.

The learned counsel contends that it will be very difficult for the petitioner to travel on each date of hearing.

The liberty is granted to the petitioner to serve the respondent through his counsel Sh. Manjit Kumar Jain, at District Courts, Jalandhar.

As the respondent has not entered appearance, the facts noticed

in the order dated 13.09.2021 remain uncontroverted, hence, the petition is allowed.

The petition filed under Section 9 of the Hindu Marriage Act, 1955, bearing case No.HMA/32/2021, titled as “Baljit Singh vs. Karamjit Kaur”, pending in the Family Court-I, Jalandhar, is ordered to be transferred to the Court of competent jurisdiction at Ludhiana.

The transferor Court is requested to remit the case file to the transferee Court forthwith.

The parties through their counsel are directed to appear before the transferee Court on 03.11.2021.

All the pending miscellaneous applications, if any, are also disposed of.
