CRWP-8927-2021

Present petition has been filed for seeking direction to the  
respondents No.2 and 3 to protect the life and liberty of the petitioner, as  
he apprehend danger to his life & liberty from respondent No.4.

Learned counsel for the petitioner submits that minor son of the petitioner was beaten by respondent No.4 without any reason and the said act was also brought to the notice to the police authorities. Learned counsel for the petitioner further submits that respondent no.4 is threatening the petitioner for withdrawing the complaint and he apprehends threat to his as well as his son's life and liberty.

Learned counsel for the petitioner submits that in respect of the said fact, petitioner has already raised the grievance before the higher authority i.e. respondent No.2-Senior Superintendent of Police, Tarn Taran, by filing a representation dated 25.08.2021 (Annexure P-3), which is still pending consideration with the said authority and the petitioner will be satisfied, at this stage, in case a time bound direction is issued to respondent No.2 to decide the representation dated 25.08.2021 (Annexure P-3) by passing an appropriate speaking order.

Notice of motion.

Mr. Sandeep Singh Deol, Deputy Advocate General, Punjab, who has joined the proceedings through video conference, keeping in view the service of advance copy of petition accepts notice on behalf of respondent-State.

Learned State counsel raises no objection with regard to prayer of the petitioner for deciding the representation dated 25.08.2021 (Annexure P-3) by respondent No.2 in a time bound manner by passing an appropriate speaking order.

In view of the above, without expressing any opinion on the merits of the case or the claim being made by the petitioner in

representation dated 25.08.2021 (Annexure P-3), respondent No.2 is directed to decide the representation dated 25.08.2021 (Annexure P-3) by passing a speaking order within a period of eight weeks from the date of receipt of a copy of this order.

Present writ petition stands disposed of.

It will be appreciated in case respondent No.4 is called before passing the order on the representation filed by the petitioner.
