By this petition, the petitioners seek quashing of FIR no.121 dated 13.3.2021, registered at Police Station Meham, District Rohtak, for the alleged commission of offences punishable under Sections 420/406/201/120-B of the IPC, as also all other subsequent proceedings arising therefrom, on the basis of a compromise arrived at between the petitioners and respondent no.2. A copy of the compromise deed has been annexed as Annexure P-2 with the petition.

The affidavit filed by the Deputy Superintendent of Police, Rohtak, dated 07.12.2021, is ordered to be taken on record.

Pursuant to the order dated 21.09.2021, the report of the learned Sub-Divisional Judicial Magistrate, dated 13.10.2021, is on record, stating to the effect that the “statement of the parties” were recorded to the effect that they have compromised the matter with each other; and in the assessment of that court, the compromise has been entered into without any pressure or coercion.

The identity of the parties is also stated to have been established by that court.

A perusal of the FIR would show that other than the complainant, there does not seem to be any other person aggrieved of the matter, which learned counsel for the complainant also reiterates.

That being so, looking at the nature of offences alleged to have been committed, with the matter having been amicably settled between the parties, the petition is allowed and FIR No. 121, dated 13.03.2021, registered at Police Station Meham, District Rohtak, for the alleged commission of offences punishable under the provisions of Sections 420/406/201/120-B of the IPC, along with all proceedings emanating therefrom, is hereby quashed.

By this petition, the petitioner seeks the concession of 'pre-arrest bail', upon the aforesaid FIR No. 121, having been registered at Police Station Meham.

With the FIR itself having been quashed hereinabove, in view of the settlement reached between the parties, this petition has been rendered

infructuous and is disposed of as such.
