In the present petition, the petitioner has made allegations against her husband-respondent No.4 that he is abusing not only her but, her children as well and the petitioner is living separately since 2018 in a rented accommodation in District Roopnagar due to the maltreatment meted out to her by respondent No.4. Learned counsel for the petitioner submits that husband of the petitioner i.e. respondent No.4 has come to know about the said rented residential address of the petitioner and he came to the said address and not only assaulted her but threatened her as well.

Learned counsel for the petitioner submits that the petitioner has already submitted a representation dated 06.05.2021 (Annexure P/1) to the respondent No.2/Senior Superintendent of Police, District Roopnagar bringing to their notice the said incident as she fears threat to her life and

liberty at the hands of respondent No.4, which is still pending consideration with the respondent No.2 and the petitioner will be satisfied, at this stage, in case a time bound direction is issued to respondent No.2 to decide the said representation by passing an appropriate speaking order.

Notice of motion.

Mr. Sandeep Singh Deol, DAG, Punjab, who has joined the proceedings through video conference, keeping in view the service of advance copy of petition accepts notice on behalf of respondent-State and states that the representation dated 06.05.2021 (Annexure P/1) submitted to the respondent No.2/Senior Superintendent of Police, District Roopnagar will be decided within a period of eight weeks from today and in case, after the decision, it is found that any action needs to be taken, the same will also be taken without any further delay.

In view of the above, without expressing any opinion on the merits of the case or the claim being made by the petitioner in representation dated 06.05.2021 (Annexure P/1), respondent No.2 is directed to decide the representation dated 06.05.2021 (Annexure P/1) submitted by the petitioner by passing a speaking order within a period of eight weeks from the date of receipt of a copy of this order.

Present writ petition stands disposed of.
