Instant petition has been filed under Section 482 of the Code of Criminal Procedure for directing respondents No.2 and 3 to hand over the investigation of FIR No.356 dated 03.09.2021 under Sections 306 and 34 IPC, 1860, registered at Police Station Kanina, District Mohindergarh, Annexure P-1, to some Senior Police Officials as accused private respondents No.4 to 8 are threatening the petitioner and pressurizing her to enter into a compromise.

Counsel for the petitioner submits that the private respondents had obtained the signatures of Vinod, deceased, husband of the petitioner on some blank papers, which they later converted into pronotes. On account of fraud committed by them, the petitioner had instituted a complaint, wherein vide order dated 06.11.2017, Annexure P-3, the said accused have been summoned to face trial under Sections 420, 467, 468, 471 and 120-B IPC.

Due to constant threats by private respondents, the husband of the petitioner

committed suicide and FIR, Annexure P-1, has been registered on the statement of the petitioner. Counsel submits that now the private respondents are pressurizing the petitioner to enter into a compromise and she has approached the Superintendent of Police by submitting a representation dated 13.09.2021, Annexure P-4, which is not being enquired into. Counsel submits that the petitioner will be satisfied, in case, a direction is issued to the Superintendent of Police, Mohindergarh at Narnaul, District Mohindergarh-respondent No.2 to look into the representation dated 13.09.2021, Annexure P-4.

Request made by counsel has been considered.

Without examining the allegations levelled in the petition or in the representations, the petition is disposed of with a direction to the Superintendent of Police, Mohindergarh at Narnaul, District Mohindergarh-respondent No.2 to examine the representation dated 13.09.2021, Annexure P-4, and take suitable action thereon as warranted, in accordance with law.

A copy of the order alongwith the representation, Annexure P-4, be sent to the Superintendent of Police, Mohindergarh at Narnaul, District Mohindergarh-respondent No.2, so as to enable him to do the needful expeditiously.
