[1] Case is being taken up for hearing through Video Conferencing due to Covid-19 pandemic.

[2] Prayer in the petition under Section 482 Cr.P.C. is for quashing of order (Annexure P-3) dated 27.04.2009 passed by the learned Additional Sessions Judge, Gurgaon, declaring the petitioner proclaimed offender, in case FIR No.20 dated 18.01.2008 registered under Sections 307 read with Section 34 IPC and Section 25 Arms Act at Police Station Sadar, Gurgaon.

[3] Learned counsel contends that the petitioner was granted regular bail by the learned trial Court vide order (Annexure P-2) dated 25.10.2008 in the aforementioned case but could not appear in the proceedings before the learned trial Court on 27.04.2009, leading to passing of order (Annexure P-3) dated 27.04.2009, declaring the petitioner proclaimed offender.

No.875 dated 17.10.2006 under Sections 148, 149, 342, 302, 201, 120-B IPC and Sections 25/54/59 Arms Act was registered by the petitioner at Police Station Sadar Gurgaon, District Gurgaon against one well known gangster-Kaushal who has 33 criminal cases registered against him, majority of which are under Sections 302 and 307 IPC. Details of the same are as under :-

[5] Learned counsel contends that although said gangster stands convicted in FIR No.1108 dated 18.12.2006 vide judgment of conviction dated 26.05.2011 and is in custody yet he was committing crimes beyond the

Nos.13 to 32 in the list of FIRs registered against said gangster-Kaushal, as referred to above.

[6] Learned counsel contends that said gangster-Kaushal's mother had registered FIR (Annexure P-1) bearing No.20 dated 18.01.2008 under Sections 307/34 IPC and Section 25 Arms Act at Police Station Sadar, Gurgaon against the petitioner and had also threatened him with elimination through her gangster son-Kaushal and it is on account of said fear that the petitioner did not appear before the Court.

[7] Learned counsel contends that co-accused-Mahipal and Rajesh in FIR No.20 dated 18.01.2008 under Section 307/34 IPC registered at Police Station Sadar, Gurugram against whom there were identical allegations as are against the petitioner stand acquitted vide judgment (Annexure P-8) dated 14.10.2010.

[8] Learned counsel contends that the petitioner does not press the instant petition and may be permitted to withdraw the same with liberty to surrender before the learned trial Court and file a petition for regular bail with directions being issued to the learned trial Court to decide the same in a time bound manner.

[9] The same is not opposed to by learned State Counsel.

[10] Accordingly, in the light of statement of learned counsel for the parties, the instant petition is *dismissed as withdrawn* with the liberty as prayed for. In the eventuality of the petitioner surrendering before the learned trial Court and moving a petition for regular bail, the learned trial Court is directed to consider and decide the same in accordance with law, by taking into account all aspects of the matter, as expeditiously as possible.
