Petitioner has filed the instant writ petition assailing action of respondent-HSVP for having rejected his claim for allotment of a plot under the Oustee's category (vide Annexure P-9) on the ground that only 33% land of the petitioner had been acquired.

The precise case projected on behalf of the petitioner by placing reliance upon a certificate dated 20th July, 2020 (Annexure P-5) is that his entire land-holding stood acquired.

Mr. Rajesh Sheoran, learned counsel makes a statement that a decision has been taken at the hands of Chief Administrator, HSVP contained in Memo dated 16th August 2021 and as per which, cases of all the applicants are now to be re-examined. He further submits that even as regards the present petitioner, an exercise of reconsideration of his claim would be conducted.

In the light of such categorical stand taken, the impugned rejection of the claim of the petitioner does not survive.

The application already submitted by the petitioner seeking allotment of a plot under the Oustee's category be re-considered, as per the applicable policy governing the issue of oustee's and an order afresh in such regard be passed positively, within a period of 03 months from today.

Writ petition is disposed of in terms of the statement recorded of Mr. Rajesh Sheoran, Advocate for HSVP.

It is clarified that we have not examined the claim of the petitioner on merits.

Pending application(s), if any, shall also stand disposed of.
