The present appeal has been filed by the claimant seeking enhancement while seeking modification of the award dated 25.09.2013 *vide* which a compensation amounting to ₹ 1,26,000/- along with interest @ 7.5 % p.a. from the date of the filing of the claim petition till final realization, has been awarded.

As per the said award, an amount of ₹ 1,26,000/- along with interest @ 7.5 % p.a from the date of the filing of petition till actual realization along with cost have been passed in favour of the appellant/claimant. The matter has

A perusal of the above statement would show that the claimants and the Insurance Company have compromised the matter by stating that a compensation of ₹ 1,20,000/- over and above the amount already awarded by the learned Motor Accident Claims Tribunal, Kurukshetra, will be paid by the Insurance Company to the appellant/claimant.

Learned counsel appearing for respondent No.3-Insurance Company has further stated that the said amount would be paid by the Insurance Company to the appellant within a period of four weeks from today, failing

which the interest @ 9% p.a. shall follow from the date of the settlement before the Lok Adalat till the date of payment.

Learned counsel for the Insurance Company has further stated that an amount to the tune of ₹ 1,20,000/- in the name of the appellant/claimant will be deposited with the office of the Lok Adalat of this Court on or before 10.01.2022, failing which the interest @ 9% p.a. shall follow at this amount till the payment from the date of this order.

In view of the above, we are of the opinion that the compromise is genuine and *bona fide* and in the best interest of the claimants as well as all the parties concerned.

Accordingly, the appeal is disposed of as having been compromised and the compromise shall be treated as part and parcel of the award, and the order of the learned Motor Accident Claims Tribunal, Kurukshetra, stands modified in terms of the said compromise. The parties will be bound by the said compromise.

The concerned officer of the learned Tribunal shall issue proper receipt after receiving the cheque to the learned counsel/representative of the respondent-Insurance Company.
