Case is taken up for hearing through video conferencing.

Through this petition, the petitioner seeks interim regular in case bearing FIR No.45 dated 18.04.2019, registered at Police Station Kartarpur, District Jalandhar Rural, under Sections 22 NDPS Act, 1985, to attend the marriage of his daughter, scheduled to be solemnized on 14/15.11.2021.

Vide order dated 02.11.2021, this Court had directed the State to file a reply.

In compliance of the said order, status report by way of affidavit of the Deputy Superintendent of Police, Sub Division Kartarpur, Jalandhar, has been filed in the Court today. The same is taken on record.

Learned counsel for the petitioner contends that the petitioner has been in custody since 18.04.2019 and there is no other male member in his family to make arrangements for the marriage of his daughter, which is

to be solemnized on 14/15.11.2021. In such circumstances, learned

counsel prays that the petitioner be released on interim regular bail for a period of four weeks.

Learned State counsel submits that as per the said status report, the marriage of daughter of the petitioner is to be solemnized with Jatinder Singh on 14/15.11.2021, and that with regard to the solemnization of marriage, Harjeet Kaur; Sarpanch and the son of the petitioner have got their statements recorded with ASI Narinder Singh.

I have heard the learned counsel for the parties.

Keeping in view the fact that being father, the petitioner is required in the marriage of his daughter to be solemnized on 14/15.11.2021, but without going into the merits of the case, the petitioner is ordered to be released on interim regular bail w.e.f. 12.11.2021 to 16.11.2021, subject to him furnishing bail and surety bonds to the satisfaction of the learned trial Court/Duty Magistrate.

The petitioner shall surrender before the trial Court/Duty Magistrate, on 16.11.2021 at 3.00 P.M. sharp.
