As per statement of learned counsel for the appellant, the offer given by the Insurance company to the tune of Rs.1,00,000/- has been accepted by the appellant towards full and final settlement of the claim in the present appeal.

Even today, learned counsel for the parties are *ad idem* that they will stick to the proposed enhancement of Rs.1,00,000/- towards full and final settlement in the present appeal over and above the amount already awarded by the Motor Accident Claims Tribunal.

Accordingly, in the light of understanding between the parties, we dispose of this case with a direction to the Insurance Company to deposit a crossed-cheque for Rs.1,00,000/- in the name of the appellant-Saleem with the office of the Lok Adalat of the High Court within a period of four weeks, in compliance of this order, failing which, interest @ 9% per annum shall follow

on the enhanced amount of compensation with effect from the due date till final realisation of the amount. On receiving the cheque from the Insurance Company, the concerned officer/official of the Lok Adalat Branch shall issue proper receipt to the Insurance Company. The appellant/appellant's counsel may collect the cheque from the office of the Lok Adalat.

Copy of this order be supplied/sent to the counsel/parties and file be returned to the Hon'ble High Court.
