On the asking of the Court, Mr. Nikhil Chopra, Addl. AG Punjab has accepted notice on behalf of respondent No.1 while Mr. Nishant Maini, Advocate assisting Ms. Anu Chatrath, Sr. Advocate has accepted notice on behalf of respondent No.2. They have no objection in case the main petition is preponed.

In view of above, the present application is allowed. With the consent of learned counsel for the parties, main case being CWP-7226-2018 is taken on board today itself.

Ms. Anu Chatrath, Sr. Advocate appearing on behalf of respondent No.2, on instructions from Mr. Amrit Singh, Law Officer, Amritsar, states that she has no objection if the present petition is disposed of with a direction to respondent No.2 to decide the legal notice of the petitioner dated 12.05.2017 (Annexure P-4) in a time bound manner.

In view of the stand taken by learned counsel for the parties and without commenting on the merits of the case, the present petition is disposed off with a direction to respondent No.2- the Commissioner, Municipal Corporation, Amritsar - to consider the case of the petitioner and his legal notice dated 12.05.2017 (Annexure P-4) sympathetically in view of the orders already passed in similarly situated case being Annexure P-6 (dated 15.02.2016), Annexures P-8 and P-9 (dated 11.05.2021) expeditiously, in accordance with law, and in any case within a period three months from the date of receipt of a certified copy of this order.
