On request, the case has been taken up in Bi-Monthly Lok Adalat through video conferencing.

The appellant and respondent No.2-Insurance Company have arrived at compromise in the Lok Adalat and as per statements of learned Counsel for the appellant and learned Counsel for respondent No.2, under the compromise a sum of Rs.25,000/- is agreed to be paid by respondent No.2 to the appellant over and above the amount awarded by the Motor Accidents Claims Tribunal in full and final settlement of the claim in this appeal.

Accordingly, the appeal is disposed of in terms of the above compromise with a direction to respondent No.2-Insurance Company to pay amount of Rs.25,000/- over and above the amount awarded by the Motor Accidents Claims Tribunal in full and final settlement of the claim of the appellants. Respondent No.2-Insurance Company shall pay the above said amount by crediting the same into the account of the appellant through RTGS or any other digital mode within one month from the date of this order failing which the amount of Rs.25,000/- shall be recoverable with interest at the rate of 9% per

annum from the date of this order till realization. Particulars of bank account of the appellant shall be furnished by learned Counsel for the appellant to learned Counsel for respondent No.2-Insurance Company within 7 days from the date of this order and in case of his failure to do so, payment may be made by respondent No.2 by way of demand draft drawn in favour of the appellant.

Copy of this order be supplied to the learned Counsel for the parties and file be returned to the High Court.
