This application has been filed under Order XXIII Rule 3 read with Section 151 of CPC by the applicant-respondent No.3 for preponing the case and disposing of the same in terms of compromise.

Since the main case is listed for today, the application qua preponement is dismissed as infructuous. Qua remaining prayer for disposing of the appeal in terms of compromise is allowed, as prayed for.

CM-3067-CII-2017

This is an application filed under Section 5 of the Limitation Act for condoning the delay of 501 days in filing the appeal.

Notice of the application.

Mr. Punit Jain, Advocate for the applicant-respondent No.3, accepts notice of the application and submitted that he has no objection if the application is allowed.

For reasons mentioned in the application and in view of no objection by the counsel for respondent No.3, the delay of 501 days in filing the appeal is condoned.

The application stands allowed accordingly.

CM-3068-CII-2017

This is the application filed under Section 151 CPC for seeking exemption from filing the true typed copy of the Award dated 07.03.2015 passed by MACT, Kaithal.

The application is allowed, as prayed for.

Main Case

The instant appeal has been filed by the appellant-injured person namely, Manoj for setting aside the award dated 07.03.2015 whereby the claim petition filed seeking compensation has been dismissed.

Now, it has been submitted by counsel for respondent No.3- Insurance Company that the parties have amicably settled the dispute, under which the respondent No.3 has agreed to pay an amount of ₹10,000/- as full and final settlement.

Counsel for the appellant has not disputed the above settlement between the parties and has expressed his no objection, to the disposal of the present appeal in terms of the compromise.

In view of the above, the present appeal is disposed of in terms of the above said compromise, by awarding an amount of ₹10,000/- as full and final settlement. It is further ordered that respondent No.3 shall deposit the above-said amount of ₹10,000/- before the concerned Tribunal, within a period of four weeks from today. The Tribunal shall disburse the same to the claimant, in accordance with law.
