Prayer in this writ petition is for a direction to the respondent authorities to include the name of the petitioners in the list of selected candidates of PGT Sociology under Category No. 17, pursuant to Advertisement no.4, dated 28.06.2015, as some of the selected candidates are stated to have submitted affidavits Annexures P-4 to P-6, to the effect that they are already working on other posts and their candidature may be cancelled. The petitioners claim to be eligible as per waiting list dated 01.07.2021, Annexure P-7.

Petitioners, it is submitted had applied for the post of PGT Sociology, pursuant to Advertisement no.4/2015 and they are reflected in the waiting list issued on 01.07.2021, Annexure P-7 (Petitioner no.1 Roll No. 51700250 and Petitioner no.2 Roll No.51700911).

Learned counsel for the petitioners submits that pursuant to revision of result, controversy regarding the matter had been raised by some of the candidates due to rejection of their candidature on account of their confidential result not being considered. The matter has attained finality pursuant to judgement of the Hon'ble Supreme Court in **Priyanka and**

others Vs. State of Haryana and others, in Civil Appeal Nos.5065-5095 of 2021, decided on 01.09.2021. Subsequent thereto some of the successful candidates selected for the post of PGT Sociology have submitted their affidavits to the respondents declaring that as they already stand selected for other posts, they are not interested for appointment and they seek cancellation of their candidature. The petitioners, it is submitted approached the authorities for appointment, but their grievance, is not being considered. Representation, it is submitted was personally handed over to the authorities, but copy thereof was not retained by them.

Notice of motion.

Mr. Randhir Singh, Addl.AG., Haryana, accepts notice on behalf of the respondent-State. Advance copy of writ petition stand supplied.

At this stage, learned counsel for the petitioner restricts the prayer for a decision on the petitioners claim, in a time bound manner.

Learned counsel for the respondent-State does not raise any serious objection to the restricted prayer.

Keeping in view the limited prayer addressed, facts and circumstances of the case but without expressing any opinion on the merits of the case, this writ petition is disposed of with a direction to the competent authority, to consider the present writ petition as representation on behalf of the petitioners and consider their claim in accordance with law, within four weeks from the date of receipt of certified copy of this order.
