This order shall dispose of CRM-M No.43230 of 2019 titled as  
Jaswinder Kaur v. State of Punjab & CRM-M No.30381 of 2019 titled as  
Shimpy v. State of Punjab.

The petitioners pray for grant of anticipatory bail in FIR No.129  
dated 21.06.2019, registered under Sections 419/420/34 of IPC at Police  
Station Civil Lines, Bathinda, District Bathinda.

Counsel for the petitioners have shortly argued that FIR was registered on a complaint given by Veena Rani that the accused persons had cheated her for the amount on the basis of agreement to sell as the seller later on refused to get the sale deed executed.

It is worth noticing that the petitioner-Jaswinder Kaur was granted interim bail on 07.10.2019 and the petitioner-Shimpy was granted interim bail on 19.07.2019.

Counsel for the petitioners have submitted that, in pursuance to the order dated 07.10.2019 passed in CRM-M No.43230 of 2019 and the order dated 19.07.2019 passed in CRM-M No.30381 of 2019, both the petitioners have appeared before the Investigating Officer and have joined the investigation.

Learned State counsel assisted by counsel for the complainant, on instructions from ASI Parminder Singh, has not disputed the aforesaid fact and submits that both the petitioners are no more required for further investigation.

Even otherwise, the interim order passed way back in 2019 and there is no allegation that the same has been misused by the petitioners in this manner.

In view of the above, both the aforesaid petitions are allowed and the interim bail granted to petitioner-Jaswinder Kaur in CRM-M No.43230 of 2019 vide order dated 07.10.2020 and the interim bail granted to petitioner-Shimpy in CRM-M No.30381 of 2019 vide order dated 19.07.2020 are made absolute subject to the conditions envisaged under Section 438(2) Cr.P.C.
