1. This order shall dispose of the aforesaid five petitions filed on behalf of the petitioners, namely, Amit Sharda, Rinku Verma, Pinku Verma, Ajay Patyal and Pankaj Khanna, seeking grant of anticipatory bail in respect of a case registered against them vide FIR No.279 dated 23.11.2019 at Police Station Sector-14, Panchkula, under Sections 406/420/120-B IPC.
2. Today, learned State counsel has informed that all the petitioners pursuant to interim directions issued by this Court have joined investigation and that they have been found innocent.
3. In view of the aforestated position, all the petitions are disposed of with a direction that in case, at any subsequent stage, the petitioners are required to be arrested, the State shall give one week's prior notice before effecting their arrest.
