Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

(A) A writ in the nature of certiorari or any other writ/s, order/ s, direction/s, for quashing the decision of the Contractor Selection Committee, Midday Meal Scheme, Kaimur, taken in it's meeting dated 21.11.2019, by which the tender of Soni Devi @ Usha Devi, respondent no. 5 has been selected as contractor, for transportation of food grains from the godown of State Food Corporation to the store rooms of schools falling within Bhabhua block of Kaimur district by treating her tender legal which was in violation of the terms and conditions of the tender notice.

(B) A writ in the nature of mandamus or any other writ/s, order/ s, direction/s, for issuance of directions to the respondents for the following : -

(i) To hold that decision of the Contractor Selection Committee, Midday Meal Scheme, Kaimur, taken in it's meeting dated 21.11.2019, with respect to the selection of Soni Devi @ Usha Devi, respondent no. 5 is illegal and without jurisdiction.

(ii) To stay the operation of decision of the of the Contractor Selection Committee, taken in it's meeting dated 21.11.2019, contained in Annexure - 2, by which respondent no. 5 has been selected as contractor, for transportation of food grains from the godown of State Food Corporation to the store rooms of schools falling within Bhabhua block of Kaimur district.

- (iii) To hold that tender of only petitioner is valid one and she is entitled to be selected as a contractor, for transportation of food grains to the storerooms of schools in Bhabhua block of Kaimur district.
- (iv) To select the petitioner as a contractor, for transportation of food grains from the godown of State Food Corporation to the store rooms of schools falling within Bhabhua block of Kaimur district.
- (C) Any other relief/s for which the petitioner is found entitled to.

Learned counsel for the petitioner seeks permission to withdraw this petition.

Permission is granted.

This petition is disposed of as withdrawn.
