Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

“1(A) For payment of bill of Rs. 4,54,400/-
(Four Lakhs Fifty Four Thousand Four Hundred Rupees only) along with interest for submitting detailed project for infrastructure development of the College.

(B) Any other relief or reliefs for which



petitioner may be found entitled to in the fact and circumstances of the present case may be granted to him.”

After the matter was heard for some time, finding the Court not to be in favour with the submissions made across the Bar, learned counsel for the petitioner, seeks permission to withdraw the present petition reserving liberty to take recourse to alternative remedy in accordance with law.
