That this is an application to declare Ultravires part portion of the notification at page 10 Item No. 11 of the said notification dated 29.12.2016, inserting sub Rule 2 in Rule 62 of the Central Motor Vehicle Rule-1989, published in the India Gazette (Extra ordinary), dt- 29.12.2016, whereby and whereas the Govt of India modified in Central Motor vehicle Rule 62 (2) imposing a fee of Rs. 50.00 in guise of penalty each day in between the expiry of the last certificate of fitness day to the day granted or renewed the next fitness by the Motor vehicle Inspector or the Testing Station under section 56 of the Motor Vehicle Act 1988.
