3 19-09-2022 Petitioner has prayed for the following relief(s):

“i. For quashing of letter contained in Memo No. 2420 dated 31.12.2019 whereby and where under the Executive Engineer, Shahabad Road Division, Ara while exercising power under Clause-33.2 of general condition of



contract has debarred the petitioner from participating in future tender with direction to petitioner to repair Ara-Eakauna-Khaira-Sahar Road otherwise as per agreement, action shall be taken to rescind the agreement.

ii. For direction to the respondent authorities to delete Ara-Eakauna-Khaira-Sahar Road from petitioner's OPRMC, Package No. 34B, Bhojpur, Shahabad allotted to the petitioner.

iii. For any other relief/reliefs for which the petitioner is found entitled to."

Learned counsel for the petitioner, under instructions, seeks permission to withdraw the present petition.

Prayer allowed.

Petition is disposed of as withdrawn.

Interlocutory application(s), if any, shall also stand disposed of.
