The petitioners have prayed for the following



relief/s:-

(i) Issuance of an order, direction or an appropriate declaration, declaring Sub-Rule (v) of Rule 656 of the Bihar Police Manual, 1978 in so far as it prescribed that minimum qualifying height for female candidates be 160 cm and weight 48 kg for appointment on the post Sub-Inspector/ reserve Sub-Inspector of Police in the State of Bihar, as amended vide notification no.4/B1-101/2004-7025 dated 30.08.2017.

(ii) Issuance of an order, direction or writ in nature of Mandamus commanding the respondent authorities to make selection of female candidates on the post of Sub-Inspector of Police as it existed/ stood prior to the amendment dated 30.08.2017.

(iii) Any other relief or reliefs as the petitioners may be found entitled to in the facts and circumstances of the case.

Learned counsel for the petitioners very fairly states



that with the passage of time, the present petition has become infructuous.

As such, present petition stands disposed of having become infructuous.

Interlocutory application, if any, also stands disposed of.
