Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

- I. For a Direction upon the Respondents to decide the representation filed by the petitioner on 22.12.2021 before the State Election Commission, Bihar, Patna, (Respondent No. 3) to declare the Panchayat Election Jigna Jagannath Gram Panchayat, Block – Hathua, District – Gopalganj, in the year 2021 as invalid / void which was conducted contrary to the rule and circular issued by the Govt. of Bihar as well as guidelines issued by the Respondent Election Commission Bihar Patna without CCTV Camera and arrangement as well as through the wrong voter list in which 354 dead persons had been included as voter with the connivance of present B.L.O. Jigna Jagannath Gram Panchayat and 174 persons had been made voters in more than two different wards in the same Village Panchayat whose votes have been casted on the basis of which wrong elected public representatives has been declared.
- II. Any other relief / reliefs of the Petitioner may found entitled be given to him under the facts of the case.

Finding the Bench not to be in favour with the submissions made across the Bar, learned counsel for the petitioner seeks permission to withdraw the present petition reserving liberty to agitate the matter before the appropriate forum.

Permission granted.

The present petition stands disposed of as withdrawn



with the liberty aforesaid.
