This application, under Article 226 of the Constitution of India, has been filed to challenge a notification dated



28-12-2021, whereby the Urban Development and Housing Department, Govt. of Bihar, has declared its intention to extend the area of Chapra Municipal Corporation by inclusion of certain *Gram Panchayats* within its area.

2. Mr. Y.V. Giri, learned senior counsel appearing on behalf of the petitioners, has submitted that till date final notification has not been issued under Sections 6 and 8 of the Bihar Municipal Act, 2007 (for brevity 'the Act'), though objections have been filed under Section 5 of the Act by the inhabitants.

3. After some argument, in the light of Division Bench decision of this Court in case of *Usha Devi and Ors. vs. The State of Bihar & Ors.* in *C.W.J.C. No.7446 of 2021*, he seeks permission to withdraw this application with a liberty to question final notification, if situation so warrants.

4. This application stands dismissed as withdrawn with the aforementioned liberty.
