Heard learned counsel for the parties.

Petitioners have prayed for the following relief(s):-

- (i) For issuance of an order/orders, direction/directions, writ/writs specially in the nature of Mandamus for provide to insured amount of agriculture compensation to the petitioners whereby and where under the insured amount was not provided to the petitioners after destroying the crops by flood for the year 2015.
- (ii) For direction to the concern authority to exercise for fair dealing in the Agricultural Insurance System.
- (iii) For any other relief/reliefs for which the petitioners may be entitled in the facts and circumstances of this case.

Impugned order dated 07.12.2021 stands passed by the District Consumer Forum, Motihari, against which a remedy of appeal is available before the State Consumer Forum under the relevant statute.

We are of the considered view that all questions of fact and law can be expeditiously dealt with by the appellate forum.

As such, the present petition is disposed of, reserving



liberty to the petitioners to approach the appellate forum within a period of four weeks from today.

As and when any such petition is preferred, the same shall be decided expeditiously in accordance with law.

Since petitioners have been pursuing the present petition before this Court, the issue of limitation shall not be allowed to come in the way of consideration of such petition on merits.

Petition stands disposed of in the aforesaid terms.

Interlocutory Application(s), if any, shall stand disposed of.
