4 20-09-2022 Petitioner has prayed for the following relief(s):-

- (i) For issuance of writ in the nature of certiorari for quashing of the decision taken in the meeting of the Tender Committee of Road Construction Department on 27-12-2019 as contained in memo no. 9838 (S) dated 27-12-2019 whereby the tender documents submitted by the petitioner have been rejected in the technical bid and a direction has been issued for re-tender of the entire work.



- (ii) For necessary direction upon the respondent authorities to allot the work of “widening and strengthening work in KM 26.300 to 39.325 in Runnisaidpur-Katra-Keotsa road” package no.BR23RC-125 Part-II as published by the Executive Engineer, Road Division-2, Muzaffarpur vide tender notice dated 18-08-2018 as the petitioner was only successful bidder for the work.
- (iii) For holding that the technical bid was required to be evaluated in reference to Standard Bid Document of the Pradhan Mantri Gram Sadak Yojna and not any other instruction issued by the Govt. of Bihar under the Public Works Department.
- (iv) For restraining the respondents from issuing fresh tender notice for the work of widening and strengthening work in KM 26.300 to 39.325 in Runnisaidpur-Katra-Keotsa road” package no.BR23RC-125 Part-II.
- (v) For any other direction, which your Lordships may deem fit and proper in the facts and circumstances of the case.

Learned counsel for the petitioner seeks permission to withdraw the present petition, for the same having rendered infructuous.

Permission granted.

The instant petition stands disposed of as withdrawn.
