Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

- i. For issuance of order(s)/direction(s)/writ(s), particularly in the nature of writ of certiorari, for quashing of Notice Inviting Tender (NIT) No. 1 dated 02.01.2020 which has been published for selection of Transportation-cum-Handling Contractors (Main) for the district of Samastipur ignoring the fact that petitioner has been kept on stand-by mode and has been anticipating work orders from the respondents as being empanelled contractor ready to work on lowest rate.
- ii. For issuance of order(s)/direction(s)/writ(s), particularly in the nature of writ of mandamus, upon the respondent authorities to assign work to the petitioner in view of clause 11(xxii)(a) & (b) of Notice Inviting Tender (NIT) No. 816 dated 27.09.2018 which goes to say that the District Transport Committee can take work from the empanelled contractors, violating which the respondents are taking work of Transportation-cum-Handling (Main) against current vacant posts from contractors who are not empanelled contractors.
- iii. For any other relief/reliefs, order/orders & direction/ directions which the petitioner may be entitled for.

The contract NIT was issued on 27.09.2018 & 02.01.2020.

With the passage of time the contract period is over and the present petition has become infructuous.

As such, the present petition is disposed of as having become infructuous.
