2 04-08-2022 Heard learned counsel for the petitioners and the

State.

Petitioners apprehend their arrest in a case registered
for the offence punishable under Section 307/379/393 and other
allied sections of the Indian Penal Code.

FIR is against 250 to 300 unknown persons that they
pelted stones causing injury to the two constables. Some of
them made firing also.

Learned counsel appearing for the petitioners submits
that the petitioners are innocent and have falsely been
implicated in this case. They are not named in the



FIR. There is general and omnibus allegation against all the accused persons and no specific overt act has been alleged against these petitioners. Petitioners have got no criminal antecedent.

Considering the nature of allegation against the petitioners, in the event of arrest/surrender within six weeks from today, let the petitioners, named above, be released on bail on furnishing bail bond of Rs.10,000/- (ten thousand) each with two sureties of the like amount each to the satisfaction of the Judicial Magistrate 1st class, Saran at Chapra in Garkha Police Station Case No. 692 of 2021, subject to the conditions laid down under sections 438(2) of the Code of Criminal Procedure.
