Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

- (i) **For Issuance of an appropriate writ in the nature of Mandamus, Commanding and directing the respondent University to pay the bill amounting Rs. 24,99,000 + 24,99,000 = Rs. 49,98,000/- against the supply of Blank Answer Books -32 pages, to the University in view of order of the University vide letter dated 27.3.2021 and 21.06.2021 respectively and also pay the interest on account of delay made in payment of legitimate dues of the petitioner.**



- (ii) For issuance of any other appropriate writ/writs, order/orders, direction/ directions for which the writ petitioner shall be found entitled under the facts and circumstances of the case.

After the matter was heard for some time, finding the Court not to be in favour with the submissions made across the Bar, learned counsel for the petitioner, under instructions, states that the petitioner shall be content if the petitioner is permitted to withdraw the present petition reserving liberty to initiate appropriate proceedings before the appropriate forum and/or take recourse to such other alternative remedies, equally efficacious in law.

Permission granted.

We are sure that as and when any such proceedings are initiated, the same shall be considered and decided in accordance with law.

It is made clear that we have not expressed any opinion on merits. All issues are left open.

The petition stands disposed of as withdrawn with the liberty aforesaid.
