2 14-11-2022 The learned counsel for the petitioner, at the outset, has submitted that pursuant to filing of a Request Case, by the petitioner, before this Court, an Arbitrator has been appointed for adjudicating the disputes, which have arisen in between the petitioner and the respondent-State, however, the said order appointing sole Arbitrator has been challenged by the



respondent-State, by filing a Special Leave Petition bearing S.L.P.
