In the instant petition, petitioner has prayed for the fol-
lowing relief(s):-

*“(i) The petitioner seeks
direction/directions from this Hon'ble Court
to all the respondents in general and the re-
spondent No.02 to 05 in particular to pro-
vide the REVISED PAY SCALE OF Rs.5500-
175-9000 enforced from 01.01.1996 with a
retrospective effect in place of the unrevised
pay scale i.e. of Rs.1500-2750 and the same
is i.e. under challenge. Due to non grant of
the instant pay scale, the petitioner has in
has suffered a huge monetary loss in his en-*



tire retiral benefits, so he has preferred this application.”
