The petitioners apprehend their arrest in connection with Khajanchi Hat (Sahayak) P.S. Case No. 758 of 2019 registered under Sections 341, 323, 307, 379/34 of the Indian Penal Code.

Learned counsel appearing on behalf of the petitioners submits that petitioners are innocent and have falsely

been implicated in the present case. There is no specific allegation against the petitioners. Further he submits that the injuries are found simple in nature Petitioners have no criminal antecedent.
