Heard learned counsel for the parties.

Petitioner has prayed for following relief:-

(i) For issuance of appropriate writ /order/ direction Commanding the respondent authorities (Respondent No. 6 to 9) to make payment of Rs. 705369.60 with panel interest on account of delayed payment in terms of the order dated 23-12-2017(Annexure- 5) passed by District public Grievance Redressal Officer, Sitamahi, in complaint No. 404110107101703932, to the petitioner .

(ii) For issuance appropriate order /direction to take proper action in accordance with law against the erring respondent for non compliance of the order dated 23-12-2017 (Annexure-5) passed by the District Public Grievance Redressal officer , Sitamahi.

(iii) Any other relief or reliefs for which the petitioner may be entitled in the facts and circumstances of the case.

After the matter was heard for some time, finding the Court not in favour of the submissions made by the learned counsel for the petitioner, learned counsel for the petitioner, under instructions, states that the petitioner will be content if the petitioner is permitted to withdraw the present petition, with liberty to initiate appropriate proceedings before the appropriate

forum and to take recourse to such other alternate remedies which are equally efficacious in law.

Prayer allowed.

It stands clarified that all issues of fact and law are left open to be agitated before the competent authority.

The petition is disposed of as withdrawn with the liberty aforesaid.

Interlocutory application(s), if any, shall also stand disposed of.
