7 06-05-2022 I.A. No. 1 of 2022 has been filed for substitution of the legal representatives of the petitioner, who is said to have died during the pendency of the writ application. The heirs/legal representatives of the deceased petitioner have been described in



paragraph 4 of the substitution application. Vakalatnama has already been filed on behalf of the said legal representatives proposed to be substituted.
