Heard learned counsel for the parties.

Petitioner has prayed for following reliefs:-

- (i) For issuance of appropriate writ/s, Direction/s
,Order/s in the nature of certiorari for quashing of
notice dated 31.12.2021 issued under signature
branch Manager for sale of Mortgage property
published in the Hindi news paper Prabhat Khabar
on dated 01.01.2022 as well as Entire Sarfaesi
proceeding initiated against the petitioner.
- (ii) For issuance of appropriate writ/s, Direction/s,
Order/s in Nature of Mandamus for commanding
respondents to restrain themselves from sale of
Mortgage property.
- (iii) For any other relief/s to the petitioner for which
she found entitle.

After the matter was heard for some time, finding the Court not in favour of the submissions made by the learned counsel for the petitioner, learned counsel for the petitioner, under instructions, states that the petitioner will be content if the petitioner is permitted to withdraw the present petition, with liberty to initiate appropriate proceedings before the appropriate forum and to take recourse to such other alternate remedies which are equally efficacious in law.
