- i) To issue an appropriate writ(s), order(s), direction(s) in the nature of writ of Certiorari for quashing the decision dated 06.02.2020 taken by the Departmental Tender Committee of the Road Construction Department vide its Memo No. 1207 & 1208 both dated 06.02.2020 (as contained in Annexure-6 Series), whereby the petitioner has been disqualified in the technical bid of the Notice Inviting Tender No. 03/SBD/2019-20 dated 06.09.2019 issued for two works of "PR Work in Km 0 to 31.64 of Mohania-Ramgarh-Chousa Road (SH-14) for the year 2019-20" and "Strengthening work of NH-30 Mohania-Ara Road towards Parsathua Bazar to Mahavir Ashtan SH-14 Mohania-Chousa Road via Mukhrawan in KM 0 to 15.50 for the year 2019-20."
- ii) To issue an appropriate writ(s), order(s), direction(s) in the nature of writ of Mandamus directing the respondents to open the financial bid of the petitioner as the petitioner is technically qualified in the technical bid and fulfills all the terms and conditions of the notice inviting tender.
- iii) To any other relief or reliefs for which the petitioner is found to be entitled in the facts and circumstances of the case.
