Interlocutory Application No 9282 of 2018 has been filed for expunging the name of the sole petitioner who has died during pendency this writ application and in his place substituting the names of his legal heirs, as mentioned in the Interlocutory Application.

Interlocutory application No 9282 of 2018 is allowed



and the name of sole petitioner be expunged and, in his place, names of his legal heirs be substituted.

The deceased petitioner was defendant in Title Suit No 3 of 2015. It is the submission of the petitioners' counsel that the Title Suit was dismissed by learned Sub Judge I, Banka under Order VII Rule 11 of Civil Procedure Code. It is further submitted that availing benefit of the said order, the petitioners would be approaching the Authority in respect of the validity of Annexure 3, the order of mutation dated 24.01.2015.
