This matter is heard *via* video conferencing due to circumstances prevailing on account of the COVID-19 Pandemic.

Learned State counsel accepts notice for respondents.

Learned counsel for the petitioner is hereby directed to serve a copy of the petition on learned counsel for the State if it not already served.

In the instant petition, petitioner has prayed for the following relief(s):-



“(a) For issuance writ in the nature of mandamus commanding and directing the respondent authority to pay the entire honorarium for the month of

(i) January 2012 to May 2012

(ii) For May 2013 to March 2015

(iii) For August 2017 till date

(b) For issuance of direction to the respondent authority to allow her to perform her duties and make the signatures over the attendance register.

(c) For any other relief or reliefs which the petitioner found entitled thereunder.”

In support of the aforesaid relief petitioner has submitted representations on 20.10.2020 and 22.02.2021 (Annexure-11 & 11/1). The concerned respondent has not taken any decision on petitioner's representations.

The concerned respondent is hereby directed to examine the petitioner's grievance and redress the same within a period of two months from the date of receipt of this order. If the petitioner is otherwise eligible for the monetary benefits the same shall be extended along with interest @ 6% per annum. If the petitioner is not entitled in that event necessary speaking order shall be passed and communicated to the petitioner. If the aforesaid direction is



not complied within the time limit stipulated in that event concerned respondent is hereby directed to pay litigation cost to the petitioner and it is quantified @ Rs. 10,000/- (Ten Thousand).

With the aforesaid observations, the present writ petition stands disposed off.
