(A) A writ in the nature of Certiorari or any other appropriate writ/s, order/s direction/s quashing the Letter No-727 dated 25/9/2021 undersigned by Circle Officer, Sahdeo Bujurg in exercise of powers conferred upon by Sub-divisional Magistrate, Mahanar vide letter No-188 dated 18/9/2021



(B) A writ in the nature of Mandamus or any other appropriate writ/s, order/s, direction/s commanding the respondent No-3 (Circle Officer, Sahdeo Bujurg, Mahanar) to act in accordance with law and in light and prepondence of the evidences presented on record.
