Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

1. That this writ application is being filed for
issuance of a direction to the respondent authority
for dispose of the representation filed by the
petitioner on 31.08.2020 and 23.09.2020 as well
as in pursuance of order dated 22.01.2022 passed
in CWJC No.3827 of 2021 representation filed on



28.02.2022, contained in Annexure-1 of the writ application is still pending for final adjudication in spite of order passed by this Hon'ble Court. And/or pass such other order or orders as your Lordships may deem fit and proper.

After the matter was heard for some time, finding the Court not to be in favour with the submissions made across the Bar, learned counsel for the petitioner, under instructions, states that the petitioner shall be content if the petitioner is permitted to withdraw the present petition reserving liberty to initiate appropriate proceedings before the appropriate forum, including Debt Recovery Tribunal and/or take recourse to such other alternative remedies, equally efficacious in law.

We are sure that as and when any such proceedings are initiated, the same shall be considered and decided in accordance with law.
