following relief :-

*“(i) For issuance of an appropriate writ(s)/
order(s), preferably a writ in the nature of
mandamus commanding the respondents to*



forthwith remove encroachment from the public road bearing Khata no. 190, Khesra no. 203 under Mauja-Vishwaspur (945), Revenue PS-96, Circle-Dalsingsarai, Dist-Samastipur.”

At the outset, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to approach the Circle Officer, Dalsingsarai, Samastipur for redressal of his aforesaid grievance. Liberty so sought, is granted.

It is needless to state that in case, the petitioner approaches the Circle Officer, Dalsingsarai, Samastipur by filing appropriate petition under the provisions of the Bihar Public Land Encroachment Act, 1956, within a period of four weeks from today, the same shall be considered, in accordance with law and after hearing the affected parties, appropriate orders shall be passed thereon, forthwith.

The writ petition stands disposed off on the aforesaid terms.
