ORAL ORDER

2 21-09-2022 Heard learned counsel for the petitioner and learned APP for the State.

The instant application for anticipatory bail has been filed by the petitioners apprehending his arrest in connection with Turkauliya P.S. Case no. 485 of 2021 instituted for the offence under Sections 147, 148, 149, 323, 324, 341, 327, 307, 338, of the Indian Penal Code and section 27 of the Arms Act.

It is a case of assaulting to the informant and opening fire by other accused persons due to which Tuntun Thakur had sustained gun shot injury.

Learned counsel appearing on behalf of the petitioner has submitted that petitioners are innocent and have committed no offence. They have falsely been implicated in this case.



Specific allegation of opening fire is against Nawab Raja, Raushan Sahani and Bhola Sahni. As per injury report, no one received gun shot injury. There is general and omnibus allegation against the petitioner. They have got no criminal antecedent.

Learned APP appearing for the state has opposed the prayer of anticipatory bail.

Having heard learned counsel for the parties and in the facts and circumstances of the case as stated above, this Court is inclined to enlarge the petitioners on bail. The petitioners are directed to surrender in the Court below within a period of four weeks from today and in the event of their arrest or surrender in connection with Turkauliya P.S. Case no. 485 of 2021, they will be enlarged on bail on furnishing bail bond of Rs. 10,000/- (Rupees ten thousand) with two sureties of the like amount each to the satisfaction of learned Chief Judicial Magistrate, East Champaran, Motihari subject to the conditions as laid down under section 438(2) of the Cr.P.C.
