3 18-10-2022 Petitioner has prayed for the following relief(s):-

“That this is an application in a nature of a writ of Mandamus or any other writ or writs for an order or orders as well as direction or directions by the majesty of this Hon’ble Court commanding the Respondents to make the payment of pending Bills (a) amounting Rs. 5,35,248.00 (Five lacs thirty five thousand two hundred forty eight only). Bill No. 42/13-14 dated 4.3.2014 (Annexure-5, 5/1) amounting Rs. 4,20,227/- (Rupees Four lacs twenty thousand two hundred twenty seven only) against Bill No. 43/13-14 dated 4.3.2014 (Annexure-5,5/1) i.e., the total amount of Rs. 9,55,535.00 (Rupees Nine lacs fifty five thousand five hundred thirty five only) w.e.f. 2013-14 for the work done as per District Magistrate order dated 06.01.2014 vide



Sanchika XXXI-5-2013 Communicated under the signature of Dy. Election officer, Rohtas (Sasaram). And further prayer to the majesty of this Hon'ble Court to command and direct the Respondents to make the payment at the earliest as the same are arbitrarily with malafide intention has been with held."
