“1. That, the petitioner has come issuance of appropriate writ/ up for order/ direction in the nature of certiorari for setting aside the order dated 31.12.2021 passed in Supply Appeal Case No.05 of 2020 passed by the Collector, Saharsa and whereby the order of the S.D.O. Sadar Saharsa was upheld regarding suspending the Licence no.279 of 2016 of the petitioner running P.D.S. vide communicating Memo no.1564-2 dated 23.07.2020 thereafter again cancelled vide Memo no.2512-2 dated 19.11.2020 and for whether order in the nature of mandamus for



allowing/restoration the licence no.279 of 2016 and also not considered the claim of the petitioner direction has been given to the learned S.D.O. Sadar Saharsa and Collector Saharsa vide order passed by Hon'ble High Court Patna vide C.W.J.C.
