2 02-12-2022 The present writ petition has been filed for seeking
the following relief:-

“1. That this is an application for issuance of direction/commanding the Respondent to remove the Encroachment from Public Well situated on Gairmajarua Aam land bearing Khata No. 6, Khesra No. 1798 Area-8 Decimal which has been encroached by local persons who are not removing the encroachment from the above



noted public well/land situated on Gairmajarua Aam land. In spite of clear finding of the Circle Officer, Bettiah, West Champaran as well as redressal order passed by Public Grievance Cell, Bettiah and also by District Redressal Forum, Bettiah, West Champaran.”
