Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

- (i) For issuance of a writ(s) direction/s, order/s in the nature of mandamus to change the part of the 11000 K.V. main lines and there poles passing just over the heads of the roof of the house of the petitioner.
- (ii) And/Or Further to pay the compensation to the petitioner in order to purchase a home stead land and to construct a house of the similar value as he has got the only one home stead land and house over which this 11000 Volt is purposed to pass.
- (iii) For any other relief /reliefs for which the petitioner may be found legally entitled.

Learned counsel for the respondents, states that similar petition being **C.W.J.C. No. 10609 of 2020** titled as **Sushma Kumari @ Sushma Devi Vs. The Managing Director South Bihar Power Distribution Co. Ltd.** was disposed of by a co-ordinate bench of this Court vide judgment dated **17.01.2022**, and the present petition may also be disposed of in the light of the said petition.

Learned counsel for the petitioner has no objection to the same.

In view of the same, as mutually agreed, the instant
