regularize the services of the petitioners who are working on vacant sanctioned post since their date of initial appointment and for continuous working on sanctioned post and perennial requirement of works have been made to work as daily wager/or on contract and further for payment in regular scale of pay and for issuance of any other appropriate writ or writs, orders or directions to which the petitioners may be found legally entitled to.

Considering the relief(s) sought for, the petitioners are directed to file a representation before the Registrar, Purnea University, Purnea, Bihar (respondent No. 6) who shall consider the said representation and pass an appropriate order in accordance with law.

With the aforesaid observation and direction, this writ application stands disposed of.
