The present application has been filed for
modification of the order dated 11.04.2022, passed in Cr.Misc.



No. 44175 of 2021, by which the petitioners were granted anticipatory bail.

It is submitted that due to mistake, the name of the court below was typed as Additional Sessions Judge (SC/ST) Bhagalpur in place of A.C.J.M. XIth, Bhagalpur and hence the petitioners could not furnish the bail bonds.
