have filed a counter affidavit wherein it has been stated that an encroachment case no. 4/2021-2022 has already been initiated by the Circle Officer, Dariyapur, Anchal Dariyapur, District-Saran at Chhapra, whereafter notice was issued to the encroachers and since they did not file any objection thereto, action was taken against them and the encroachment in question has been removed on 23.3.2022.
