2 20-06-2022 Petitioner has prayed for the following relief(s):-



I. For directing and commanding the responding authorities for removal of the name of petitioner from pending ATR, on the basis of recommendation made by the work in-charge i.e. Executive Engineer , Rural Works Department, Work Division, Balia as contained in letter no. 242 dated 16.03.2022. (Annexure-6)

II. For restraining the respondent authorities from taking any coercive action as against the petitioner on the basis of pending ATR submitted by the inspecting officer IE (independent Engineer) on the basis of inspection done on 13.07.2018, in respect of the work which has already been completed satisfactorily in the year 2015 itself and the report which was submitted in its every column, remark is mentioned as satisfactory and more over in overall remarks column it has been mentioned as satisfactory and inspite of that in one column it has been mentioned as SRI in palce of satisfactory and to that effect a letter vide letter no. 242 dated 16.03.2022 by Exccutive Engineer concerned has already been forwarded to Superintending Engineer, Rural Works Department, Bihar Patna.

III. For commanding and directing the respondent authorities to open the Financial bid of the petitioner on the basis of report of Technical Bid committee, Headed by Superintendent Engineer, Rural works Department, Work Circle, Samastipur as contained in memo no. 510 dated 21.04.2022, for the work namely; **Construction of Road MRL13-NH 31 to RCD Road Near Mahmood Ganj viamature, Sanha (BR04P3R05) (Tender ID-116569)** under the NIT (Notice inviting Retender for Re tender (No.-RWD/PMGSY/HQ/ET/22-23/01)in which petitioner was declared successful, along with other bidders.

IV. For any other relief or reliefs for which the petitioner is entitled under law in the facts and circumstances of the present case.
